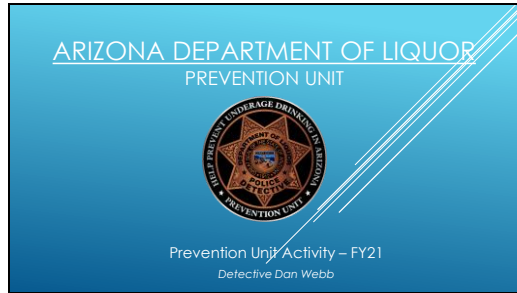
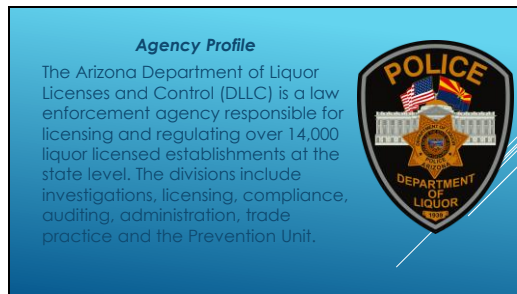


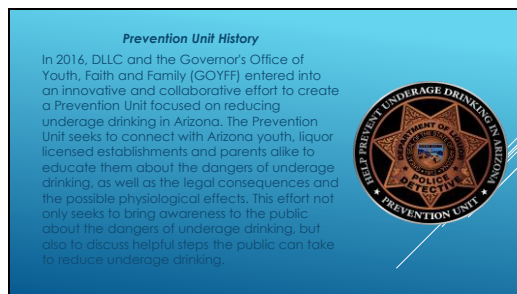

SOCIAL HOST STATUTE - ARS 4-241.Q

A person who is at least eighteen years of age and who is an occupant of an unlicensed premises is guilty of a class 1 misdemeanor if the person knowingly hosts on the unlicensed premises a gathering of two or more persons who are under the legal drinking age and if the person knows that one or more of the persons under the legal drinking age are in possession of or consuming spirituous liquor on the unlicensed premises.

DELIVERABLES FOR FY 22?



- Educate 420 establishments with in-person topic specific discussions and information dissemination such as handouts and optional sticker shock and WE ID posters
- Educate 455 teens throughout the state in relation to Alcohol Awareness
- Attend 5 community events throughout the state for information dissemination
- Educate 120 law enforcement officers in relation to liquor laws and fake ID awareness
- Identify 4 coalitions to work with statewide to rapport build and provide Alcohol Awareness class to their local schools and teen groups, provide liquor law education to the coalitions, and attend their local community events
