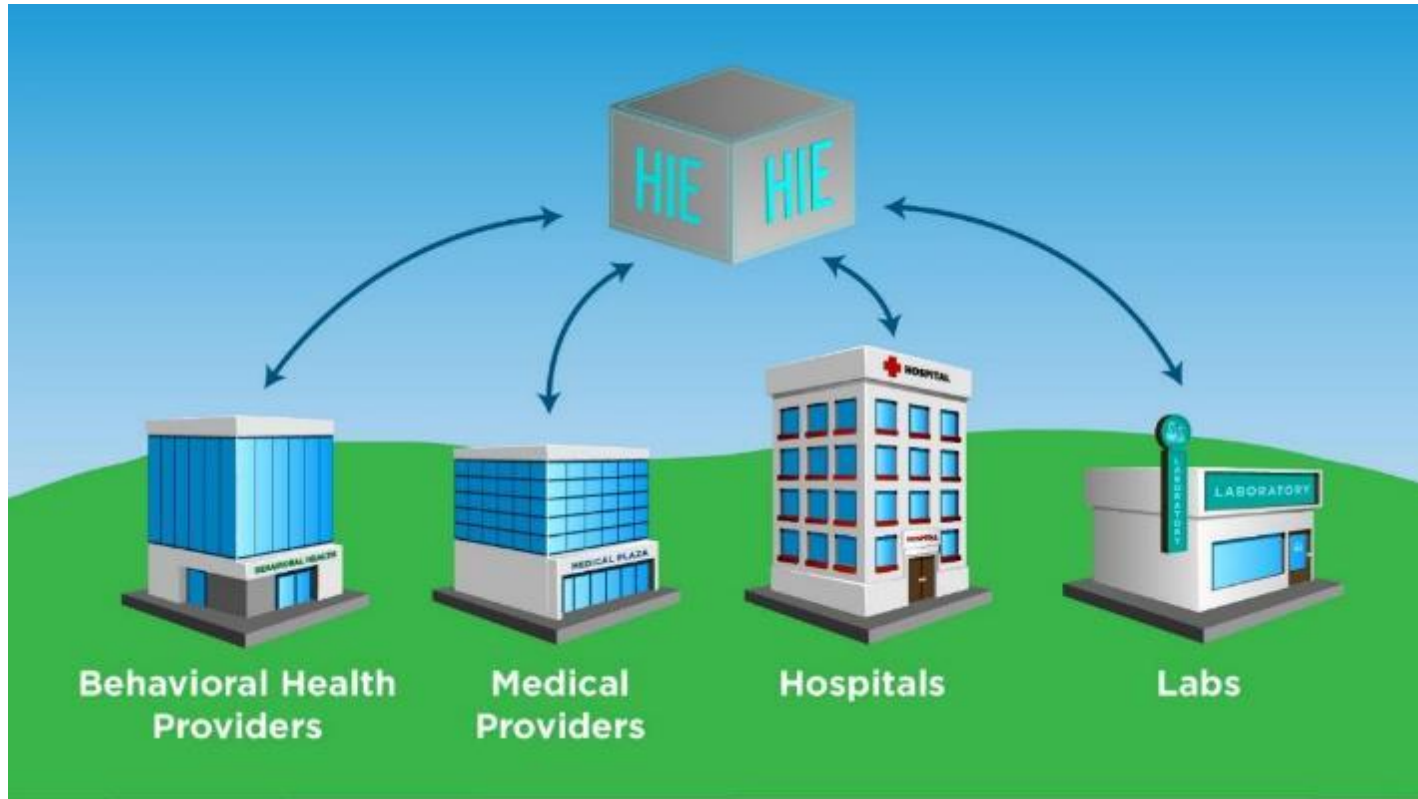

Who is Participating with Health Current?

- Over **980 HIE Participants** and growing
- Over **275 data sources** sending patient medical records for sharing, including 98% of all hospitals
- Data available on **14+ million** individuals





HIE Services


Health Current offers a range of HIE services designed to integrate more complete patient information into the care delivery of HIE Participants.

AHCCCS Whole Person Care

- Moving from medically-focused concepts of health to whole person health & wellness
- Focus Areas
 - Housing
 - Social Isolation
 - Employment
 - Food
 - Non-Emergency Transportation
 - SDOH Closed Loop Referral System (CLRS)



CommunityCares

- Connecting our communities. Facilitates screening for social risk factors
- Improving health outcomes with a whole-person care mindset. Seamlessly refers individuals to highly matched community resources
- Serves as a closed loop referral platform for social service fulfillment

What is CommunityCares?

- A resource database that organizations can adopt and access to find resources for their members/patients/clients
- A referral management tool used to send and receive referrals, provide referral feedback, and “close the loop”
- Social needs screening tools that can identify SDOH needs and maps those needs to available services in the community
- Free of cost to all who want to adopt it
- Houses over 10,000 services (and counting)

Exploring the New AzHDR

Arizona Healthcare Directives Registry

GOALS



- **Ensure person-centered end of life care**
- **For the AzHDR to be viewed as the source of truth for advance directive documents in AZ**
- **Increase in the percentage of plans held within the AzHDR. The Secretary of State registry represented only 1.6% of Arizonans over the age of 18.**
- **Increase prevalence of planning and availability for first responders and healthcare providers.**
- **Provide a key motivator for Arizonans to complete an advance directive.**
- **Increase utilization of advance directives with enhanced provider access.**

AzHDR is Available to all Arizonans

Let's Be
Direct.

- Providers do not need to be users of the Health Current HIE.
- To access the registry, providers will need to complete sign-up and onboarding paperwork and schedule training for staff.
- The registry allows for both submitting documents and viewing documents.
- User access determined by type:
 - Individual Consumers
 - Healthcare Provider/Organization
 - First Responders/EMS
 - Legal/Financial
 - Social Services/Faith-based

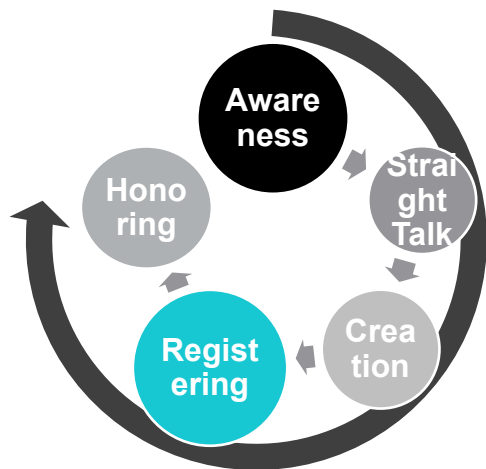


Additional AzHDR Features

- Provides a review and approval process to validate documents helping to maintain the integrity of the registry.
- Provides a mechanism for distinguishing documents that have been revoked or replaced by more recent documents.
- Supports the full range of forms under the Arizona state statute for advance directives. And supports all form types that meet this definition.
- Supports uploading of documents by consumers, once their account is set up.
- Provides ongoing support and training of organization staff.
- Offers functionality for documents to be sorted by type in each account. This eases the retrievability of the needed document.
- Simple interface that eases the burden of organizational training and onboarding.



More Than an Online Registry



Let's Be **Direct.**

- A place for healthcare providers to access tools and guides to enhance their organizations' work on advance care planning.
- With an eye toward CMS and other licensing/credentialing organizations, AzHDR will work with providers to share best practices and provide materials that help meet conditions of participation.
- The AzHDR portal will be a site that can be shared with patients and families. The educational materials available will help consumers learn ways to identify their goals, choose a decision maker, initiate difficult conversations and access Arizona advance directives.
- Many advance care planning resources are available in Arizona. The AzHDR is not duplicating these but making it easier to find them all in one location for both consumers and providers. We will also be working with organizations to identify other resources needed.
