
Affects OP, IAH, IAWH, EOP





<u>Service</u>

Court will transmit (via AOC) petition and OP to law enforcement or constable for service.



Central repository— Court Protective Order Repository (CPOR)

THE ARIZONA SUPREME COURT/AOC WILL REGISTER SERVED ORDERS WITH NCIC.

Partnership with ACJC

- ACJC drafted legislation in collaboration with stakeholders.
- Established goals of automating the protective order system, increasing number of served OPs, enlarging number of OPs reported to NCIC
- Obtained grant funds to support AOC-ITD technology project








Guided interview

- Document completion— Plaintiff Info Sheet, petition, Service of Process form
- To file, Plaintiff goes to court of choice (unless family court case pending).
- Court downloads forms from web portal; then portal is locked.
- Plaintiff can file on paper, but petition portal preferred



Features

- Can create more than one petition but only one petition/defendant
- Generates a petition number for filing.
- Floating safety button
- Computer safety information
- Information on how to obtain a new email address
- Contact information for ACESDV/NCADV and legal services
- Hover help
- Accessible on multiple devices (laptop, PC, Apple, Android, etc.)



Petition Portal

How can advocates help?

- Explain the change in the service process for OPs.
- Assist with preparation of a SAFETY PLAN.
- Talk about whether an Order of Protection should be part of the safety plan.
- Conduct a lethality assessment.



If your client wants to apply for an Order of Protection --


- Assist client with the guided interview in the AZPoint petition portal.
- Help the client obtain a new email address if necessary.

Discuss—

- Computer safety
- Whether email or text notifications are safe for the client
- Risk of saving a password on a device or computer
- Talk about the allegations with the client provide information, not advice.
- Explain the court process.
- If you have resources, support the client at court.
- Get the word out!



Rule 31, Arizona Rules of Protective Order Procedure

Effective 1/1/2020

- Court to transmit OP to law enforcement for service on same day issued...
- Unless judge makes findings—on the record—of extenuating circumstances.
- Then court must transmit for service no later than 72 hours from date of issuance.



INJUNCTION AGAINST HARASSMENT (IAH)OR WORKPLACE HARASSMENT (IAWH)

Plaintiff must arrange for service; pay fee (unless dating relationship or sexual violence).

Server must file proof of service with the court within 72 hours via Service Portal.

AZ Supreme Court is central repository; will register served IAH with NCIC.





SERVING AGENCY PROCESS

Emergency Orders of Protection

- Emergency Orders are <u>Not</u> Processed Through AZPOINT System
- Orders will expire after 72 hours
- Agencies will be responsible for entry into ACIC/NCIC
- Issuing Judge will document the Emergency OP/IAH they issue
- Agency must file certificate of service with the court
